Protecta Interior Paint FR-1 can be applied to any wood based substrate with a thickness of at least 10 mm and a density greater than 510 kg/m3. The wood based substrate can be installed with a ventilated or a non-ventilated air gap behind, as well as without air gap.

3.2 The provisions made in ETA 16/0520 are based on a working life of Protecta Interior Paint FR-1 of at least 5 years, provided that the conditions laid down in the manufacturer's instructions for the installation, use and maintenance are met.
